

Important Notice Importer Security Filing (10+2)

Effective January 26, 2009, U.S. Customs and Border Protection (CBP) requires an Importer Security Filing (ISF) <u>24 hrs prior to ocean vessel loading at foreign ports</u>. This ISF filing is separate from and in addition to the existing advance cargo declaration (24 hr Rule) and Customs entry requirements.

If an ISF Importer fails to timely, accurately, and completely submit the Importer Security Filing, that party will be subject to a claim for liquidated damages in the amount of \$5,000 per transmission. This Liquidated Damages provision will be enforced on and after January 26, 2010.

PLEASE NOTE: There can be only one ISF filer per shipment.
